

**2018 NCDP - STATE CONVENTION
MCKIMMON CENTER, NC STATE UNIVERSITY
RALEIGH, NORTH CAROLINA
JUNE 9, 2018**

State Democratic Party Chair Wayne Goodwin called the 2018 State Democratic Convention to order at 1:17PM on Saturday, June 9, 2018.

Everyone rose for Moments of Silence.

Everyone joined in the Pledge of Allegiance to the Flag.

Rhonda Bond of Wake County sang the "Star Spangled Banner."

Former Governor Martin O'Malley of Maryland gave an inspiring oration which drew repeated cheers and applause.

Secretary Melvin Williams gave the Quorum Report which showed that Delegates from 82 counties were present. The State Chair reported that more than 750 Delegates had registered.

The draft Agenda on Page 6 of the Convention Program was considered. Brenda Pollard of Durham made a motion to approve the Agenda. German de Castro of Mecklenburg seconded the motion. The motion was pass unanimously by a voice vote.

The Special Rules of the State Convention on Pages 7 & 8 of the Convention Program were brought to the floor. Scott Huffman of Mecklenburg made a motion to adopt the Special Rules of the State Convention as written in the Program. Mile Gould of Wake seconded the motion. The Special Rules were passed unanimously by a voice vote.

The Minutes of the July 11, 2018 State Convention found on Pages 10-15 were brought forth for consideration. Senator Floyd McKissick of Durham made a motion to approve the Minutes as presented. Cumberland County Chair Roberta Waddle seconded the motion. The motion to approve the Minutes was passed unanimously on a voice vote.

Kathy Manning, our Democratic candidate for Congress in the 13th District addressed the Convention.

Attorney General Josh Stein gave a speech.

All NC legislative candidates were asked to stand and receive applause.

All NCDP State Officers were recognized.

Secretary of State Elaine Marshall addressed the Delegates.

The Convention gave a prolonged standing ovation to State Representative Mickey Michaux of Durham who is completing 45 years of service in the General Assembly this year.

State Chair Wayne Goodwin told the Convention that our slate of 2 candidates in the 2018 General Election represents our diversity. He called on North Carolina to be the next state to ratify the ERA.

Anita Earls, our Democratic candidate for the Supreme Court of North Carolina, addressed the Delegates.

NC Court of Appeals candidates Allegra Collins and John Arrowood gave speeches to the Convention.

Tom Macon of Cumberland County asked if any of our Democratic candidates for NC Court of Appeals are running against each other. The State Chair assured him that they are not.

It was announced that attorney Abraham Jones of Raleigh was not going to run for a statewide judicial position this year.

Our Democratic candidate for Congress in the Eighth Congressional District, Frank McNeill made an oral presentation to the Convention.

NC College Democrats President John Easterling spoke as a proxy for Ninth District Congressional candidate Dan McCready.

NC Court of Appeals candidate Toby Hampson addressed the Convention.

The Chair of the Committee on Credentials and Appeals, Lorna Barnett of Jackson County, gave the report of her committee.

Senator Floyd McKissick of Durham delivered a lively report on the actions of the 2018 General Assembly.

Guilford County Chair Nicole Quick requested that a representative from “March For Our Lives” be given an opportunity to speak.

Angela Bridgeman of Wake asked if the 5:00PM deadline for ending the Convention could be extended. 3

ACTIONS CONCERNING WHAT TO DO WITH THE RESOLUTIONS

Randy Voller of Chatham County made a motion for the Convention to approve all Resolutions which were not pulled. Jesse Goslen of Franklin County seconded the motion. This motion was approved by a voice vote.

Bob Hyman of Wake County made a motion that all pulled Resolutions should be moved to the next SEC meeting. DNC Member Cliff Moone seconded the motion.

A lady who did not give her name said this motion should include all Resolutions not yet presented at the State Convention.

It was agreed that this motion would include all Resolutions that would be emailed to Matt Hughes by the end of the State Convention.

German de Castro of Mecklenburg County called for the question on the motion. Cliff Moone seconded the motion to call for the question. Delegates passed this motion to call for the question by a standing vote.

By a 2/3 vote the Convention then passed Bob Hyman's motion to move all pulled Resolutions to the next SEC meeting.

Matt Hughes made a motion to extend the State Convention by 10 minutes. Terrance Jones of Vance County seconded the motion. This motion was approved by a 2/3 standing vote.

Angela Bridgeman made a motion to pass a Resolution calling for the clear repeal of HB2. The Convention voted by a voice vote to carry her motion to the next SEC meeting.

Jerry Makatos of Chatham County made a motion to pass a Resolution to apply the Leahy amendment to all military personnel. The Leahy amendment forbids military aid to human rights abusers. This motion was passed by a voice vote.

Catherine Evangelista of Wake County told the Convention that we need a blitz campaign to pass the ERA. She asked would the State Chair initiate a blitz campaign? State Chair Wayne Goodwin committed to this ERA campaign.

Matt Hughes promoted the “Democrats After Dark” event which will begin at the State Headquarters at 7:30PM tonight.

The Convention was then adjourned.
